September Event Recap

GSX 2024

Global Security Exchange (GSX) took place in Orlando, FL at the Orange County Convention Center from September 23 – 25, 2024. The three-day event delivered over 200 education sessions and showcased 500 exhibiting companies.

Attendance at this year's event exceeded projections with 16,000 registrants from 86 countries. The ASIS community raised over \$31,000 for the ASIS Foundation through various events such as the Fitness Challenge and collected 83 pints of blood through a featured blood drive.

According to the Orange County Convention Center, GSX 2024 generated an estimated \$39,788,500 in economic impact for the city of Orlando.


GSX 2025 will take place in New Orleans, Louisiana between September 29 – October 1, 2025. See you there!

Legislative Update

Most bills passed during this year's legislative session took effect July 1. Below are some other measures that will take effect Oct. 1:

- **HB 549:** Makes it a third-degree felony to be part of a group of five or more people who overwhelm a merchant to conduct retail theft.
- **SB 718:** Makes it a second-degree felony for people who possess fentanyl or similar drugs that result in first responders suffering overdoses or serious injuries.
- **SB 758:** Makes changes to laws about using tracking devices, with exemptions provided under certain circumstances for law-enforcement officers, parents of minors, caregivers of seniors and vehicle owners.
- **SB 764:** Requires medical facilities and rape crisis centers to transfer sexual-assault evidence kits to the Florida Department of Law Enforcement within 30 days.
- **SB 1036:** Increases criminal penalties for immigrants who are arrested for felonies after illegally re-entering the U.S. following deportation for earlier crimes.
- **HB 1235:** Makes a series of changes related to sexual offenders and sexual predators, including changing requirements about reporting to authorities at least 48 hours before moving to another state.
- **HB 1389:** Makes changes related to digital voyeurism, including increasing criminal penalties if offenders are age 19 or older and are family members or hold positions of authority over victims.



Legislative Update

1. Artificial Intelligence (AI) in Security

Artificial Intelligence continues to play a transformative role in security, and recent legislative actions have focused on regulating AI to ensure ethical use. In 2024, over 200 bills have been proposed across various states addressing AI's application in security, ranging from autonomous surveillance to data privacy. These bills are intended to strike a balance between innovation and accountability, promoting responsible AI development while safeguarding against overregulation that could hinder access to security technologies.

2. School Safety and Security

School security has taken center stage in legislative discussions, particularly with new funding initiatives aimed at enhancing physical security in educational institutions. The emphasis is on adopting modern technologies like AI-driven surveillance, controlled access systems, and real-time threat detection to safeguard students and staff. This legislative push aligns with new standards being introduced, including those by ASIS for school security in 2024, which focus on creating safe learning environments through proactive security measures. 3. Advancements in Autonomous Security

The use of autonomous technologies such as drones and robots has gained momentum, particularly as part of efforts to address labor shortages in the security workforce. New legislation encourages the adoption of autonomous systems to perform routine surveillance, allowing human personnel to focus on more critical tasks. This hybrid approach to security, which combines human oversight with autonomous technologies, is expected to redefine physical security strategies moving forward.

4. Critical Infrastructure Protection

Legislation around protecting critical infrastructure has become more stringent, with a focus on integrating real-time data processing (on-the-spot computing) to ensure quicker responses to potential threats. This involves processing security data locally at the edge of the network, reducing the latency associated with centralized systems, and improving privacy by keeping sensitive information within geographical boundaries. This trend is driven by the need for faster, more reliable security measures in sectors like energy, transportation, and healthcare. 
